

Notice of Data Incident
September 6, 2024

On July 8, 2024, The Physical Medicine & Rehabilitation Center, P.A. (“PMRC”) experienced unusual activity on our network. We immediately began working with third-party specialists to conduct an investigation. Our investigation determined that certain information stored on our network was accessed by an unauthorized party between July 8, 2024, and July 9, 2024. Therefore, we are conducting a comprehensive review of the information potentially affected. The type of information likely varies by individual but may include name and one or more of the following data elements: address, phone number, email address, date of birth, Social Security number, drivers license/state ID number, credit/debit card number, treatment/diagnosis information, prescription information, provider name, medical record number, date of service, patient ID, Medicare/Medicaid number, treatment cost information, health insurance policy number, health insurance claim number, and health insurance information.

In response to this incident, we immediately began an investigation. Through our investigation we have notified law enforcement, reset account passwords and reviewed our policies and procedures relating to this incident. We are also providing potentially affected individuals access to credit monitoring and identity protection services as an added precaution. In general, we encourage potentially affected individuals to remain vigilant against incidents of identity theft and fraud by reviewing credit reports/account statements and explanation of benefits forms for suspicious activity and to detect errors. Under U.S. law, individuals are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. Individuals have the right to place an initial or extended fraud alert on a credit file at no cost. If individuals are a victim of identity theft, they are entitled to an extended fraud alert lasting seven years. As an alternative to a fraud alert, they have the right to place a credit freeze on a credit report. The credit freeze is designed to prevent credit, loans, and services from being approved without consent. Pursuant to federal law, individuals cannot be charged to place or lift a credit freeze on your credit report.
